NOS. 526 (WOTTON, DORKING AND CAPEL) WOLVENS LANE (D287) (PROHIBITION OF TRAFFIC) ORDER 2023

THE SURREY COUNTY COUNCIL in exercise of their powers under Sections 1 (1) 2
(1) and 2 (2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling
powers and after consultation with the Chief Officer of Police in accordance with Part III
of Schedule 9 to the Act hereby make the following Order: ——————

- 1 <u>THIS Order may be cited</u> as "The Surrey County Council Byways Open to All Traffic No. 526 (Wotton, Dorking and Capel) Traffic Regulation Order 2023" and shall come into operation on 16 February 2023
- 2 (1) In this Order unless the context otherwise requires -

"enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment

"motor cycle" has the same meaning or is to interpreted in accordance with the provisions specified for that expression in column 2 of the Table contained in the Road Vehicles (Construction and Use) Regulations 1986 (S.I. 1986/1078)

"motor vehicle " has the same meaning as in Section 136 of the Act .

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment.
- NO person shall use, cause or permit any motor vehicles or any horse drawn carriages, with four or more wheels, wider than 1500mm (4'11") from entering or proceeding in that length of the BOAT which extends from a point (A at Grid Ref. 512981 147387) 480 metres south-east of Guildford Road (A25) in a north-easterly direction for 228 metres, past point B (at Grid Ref. 513002 147398) to its junction with public footpath 129 (Dorking) and 122 (Wotton), then in a south-easterly direction for 3085 metres, past points B1 (Grid Ref 513882 146075) and C (Grid Ref. 514390 145263), to its junction

with Byway Open to All Traffic 527 (D287) at point D (Grid Ref. 515117 144087) as shown on the attached drawing 3/1/41/H52a during the prohibited period.

PROVIDED THAT nothing in this Article shall apply in relation to -

- (a) a motor-cycle
- (b) vehicles used in association with adjacent farm premises or land
- (c) any motor vehicle or horse drawn vehicle requiring access to the abovementioned lengths of BOATs 526 (Wotton, Dorking and Capel) for the purpose of exercising any statutory power or performing any statutory duty therein
- (d) any person requiring access to any premises and/or land lying adjacent to the above-mentioned lengths of 526 (Wotton, Dorking and Capel) and whose only means of ingress to which or egress from which is from the above-mentioned BOATs or any part and/or parts thereof.
- 4 <u>Gates currently installed</u> at points "B" and "C", with adjacent gaps of 1500mm (4'11") will remain in place.




